Storey Creek Golf Club (<u>www.storeycreek.ca</u>) is currently seeking an experienced and highly motivated Superintendent to lead the golf course operations team. The successful candidate will work closely with other club managers to oversee the club's operations and will report directly to the Board of Directors.

Storey Creek and Campbell River

Storey Creek, known as a "Course in Nature," is a distinguished semi-private championship golf club located on Vancouver Island flanking the southern edge of Campbell River, BC. Established in 1989, the golf club is governed by the Storey Creek Golf and Recreational Society, a non-profit organization.

The club boasts a very active and robust membership base of approximately 700 shareholders. Thanks to the maritime climate, the course remains operational year-round, accommodating approximately 50,000 rounds annually. Campbell River is a rapidly growing community with a population of 40,000, offering access to exceptional outdoor activities such as world-class salmon fishing, boating, skiing, and mountain parks.

Job Overview

The Golf Course Superintendent will be a proactive leader responsible for managing an annual budget of approximately \$1,350,000 and overseeing all facets of golf course maintenance and agronomy.

Key responsibilities include formulating and implementing annual capital and operational budgets, providing leadership and mentorship to staff, managing turf care, irrigation systems, drainage, and overall course operations. The position also requires the development of a strategic long-term course improvement plan in collaboration with the Board of Directors.

The successful candidate will join a team that includes the Head Golf Professional, Business Manager, and Food and Beverage Manager. Each manager reports directly to the Society's Board of Directors. Collectively the team is responsible for handling the daily operations of the club.

They will also prepare and manage annual budgets in alignment with the club's goals. Environmental stewardship and sustainability are important objectives in relation to improving the quality of the golf course. The initial start is on or before **October 1, 2025.**

- Minimum of 3 years as a Superintendent or 5 years as a 1st Assistant Superintendent
- A 4-year Turf Management Degree, 2-yr Diploma or equivalent qualifications
- Expertise in turfgrass management, irrigation systems, fertilizer and pesticide applications
- Strong leadership and mentoring skills to support the operations team
- A team player with good interpersonal and communication skills
- Financial management knowledge to develop annual budgets, provide forecasting and implement cost control
- Good computer skills including knowledge of current industry software applications
- Pesticide Application certificate
- Mechanical experience associated with turf care equipment
- Good knowledge of golf course design and architecture
